The draft of the notification, which the Bihar State Wetland Authority (BSWA) proposes to issue in exercise of the powers conferred under rule 7 of the Wetlands (Conservation and Management) Rules, 2017 read with Environment (Protection) Act, 1986 (29 of 1986), is hereby published for the information of the persons likely to be concerned or affected thereby; and notice is hereby given that the said draft notification shall be taken into consideration on or after the expiry of a period of sixty days from the date on which copies of the Official Gazette containing this notification are made available to the public;

Any person interested in making any objection or suggestion, on the proposals contained in the draft notification may forward the same in writing, for consideration of the Government of Bihar, within the period so specified to the Member Secretary, Bihar State Wetland Authority, at email address: cfcc.bih@gmail.com

Draft Notification

Notification No.

1. Whereas, there exists a water body known as **(Baghar Bill, Katihar)** measuring an area of 72600 sq. mts., located in the village – Surapar Tal, Panchayat – Uttari Kantakosh, Tehsil – Manihari, District – Katihar of State of Bihar, which is considered to be critically significant for its ecosystem services and biodiversity values for the local communities and society at large **(hereinafter referred to as the “Baghar Bill, Katihar”)**; which is more particularly described in the Schedule I herein.
2. And whereas, it is considered that for sustaining these values, the ecological character of wetland ecosystem needs to be maintained by regulating developmental activities within the wetland as well as within its zone of influence;
3. And whereas, in terms of sub-rule (1) of rule 7 of the Wetlands (Conservation and Management) Rules, 2017, the Environment Department of Government of Bihar prepared a Brief Document for identifying the said as **(Baghar Bill, Katihar)** wetland;
4. And whereas, based on the Brief Document Bihar State Wetland Authority (BSWA) in the 2nd meeting of the BSWA has recommended the Government of Bihar to notify the said (Baghar Bill, Katihar) as wetland under the provisions of Wetlands (Conservation and Management) Rules, 2017.

5. And whereas, the recommendation of the district Wetland Committee has been obtain from Divisional Forest Officer, Purnia vide Letter No. 2371 dated 23.09.2023 to notify this area as a wetland under the provisions of Wetlands (Conservation and Management) Rules, 2017.
6. Now therefore, the State of Bihar accepts the recommendation to declare the said wetland for being covered under the provisions of Wetlands (Conservation and Management) Rules, 2017.
7. The extent of the wetland and its zone of influence is described in Schedule I of this notification;
8. Activities prohibited within the wetland and its zone of influence is listed in Schedule II of this notification. Such prohibitions shall not apply for areas designated under other Acts and Rules, and listed at para 1.2 (a), (b) and (c) of Schedule I. Relevant provisions of respective Acts and Rules shall apply in such areas.
9. Activities regulated within the wetland and their zones of influence, i.e. permitted only with permission of State Government are listed in Schedule III of this notification. Request for permissions can be made to the Member Secretary, Bihar State Wetland Authority, C/o Department of Environment, Forest and Climate Change, Aranya Bhawan, Shaheed Peer Ali Khan Marg Patna, Bihar- 800014 or at email -ccfcc.bih@gmail.com. Such regulations shall not apply for areas designated under other Acts and Rules, and listed at para 1.2 a), b) and c) of Schedule I. Relevant provisions of respective Acts and Rules shall apply in such areas.
10. Activities permitted within the wetland and its zone of influence is listed in Schedule IV of this notification. Such permissions shall not apply for areas designated under other Acts and Rules, and listed at para 1.2 a), b) and c) of Schedule I. Relevant provisions of respective Acts and Rules shall apply in such areas.
11. The Bihar State Wetland Authority and the Ministry of Environment, Forest and Climate Change shall monitor the enforcement of the provisions of this notification.

1.5. For the purpose of this wetland known as the said **Baghar Bill, Katihar** the Zone of Influence is located within Revenue village Surapar Tal, Manihari, Katihar, Bihar.

Schedule II

List of activities prohibited within wetland boundary

1. Conversion for non-wetland uses including encroachment of any kind;
2. Setting up of any industry and expansion of existing industries; with the exception of modernization of existing industries which will not affect the ecological balance of the wetland under consideration;
3. Manufacture or/and handling or/and storage or/and disposal of construction and demolition waste covered under the Construction and Demolition Waste Management Rules, 2016; hazardous substances covered under the Manufacture, Storage and Import of Hazardous Chemical Rules, 1989 or the Rules for Manufacture, Use, Import, Export and Storage of Hazardous Micro-organisms Genetically engineered organisms or cells, 1989 or the Hazardous Wastes (Management,

Handling and Trans boundary Movement) Rules, 2008; electronic waste covered under the E-Waste (Management) Rules, 2016;

4. Solid waste dumping;
5. Discharge of untreated wastes, chemical fertilizers, pesticides, effluents and any other chemicals effecting the ecological character of the wetland from industries, cities, towns, villages and other human settlements;
6. Any construction of a permanent nature except for boat jetties within fifty meters from the mean high flood level observed in the past ten years calculated from the date of commencement of these rules; and,
7. Poaching;
8. Extraction of soil, mud, rocks for commercial purpose.
9. Fishing activities

[Any other activity other than mentioned above if taken up in the surrounding area that will have a direct or an indirect adverse effect on the ecological character of the wetland including water quality the same shall be prohibited.]

Approval of the BSWA shall be obtained for any other activity proposed to be conducted other than those mentioned above which may adversely affect the ecological character of the wetland.

Approval of the BSWA shall be taken for any other activity to be conducted other than those mentioned above.
